Newtesol S.L. (before Newtesol S.L.U, before "Nuevas Tecnologías de Soldadura S.L.") (hereinafter, Newtesol) is specialized in the manufacturing of pressure vessels and machined-welded components for the Nuclear and Petrochemical industry, as well as weld overlay/clad, welding services, pipeline fabrication and internals, in special and conventional materials.

Below mentioned Newtesol's Policy is implemented and maintained at all levels of the Company and it is periodically checked for continuing suitability during the Management Review.

The Newtesol's Policy in regards to the Safety, Quality and Environment is to develop engineering, manufacturing and post-service activities considering the Nuclear Safety Culture (See Exhibit 1.2.) as overriding priority, to guarantee firstly safety in terms of Legal and Regulatory requirements, as well as good practices, followed to provide high Quality products and services in fulfilment with the most restrictive Standards and Codes, contractual requirements and needs for satisfaction of our customers and also aim to integrate the activity of our Company within the legal framework, promoting the good environmental practices and the recycling of the waste materials.

Our total commitment to Quality is the basis of our Quality System according to ISO 9001:2015 and within this framework and in continuous improvement, Newtesol become consolidated and obtained other approval certifications in ISO 14001:2015, ISO 3834-2, API Q1 Monogram 5LD-0073, ASME VIII (U/U2 Stamp) and ASME NPT certification (ASME III Nuclear stamp). It has placed us among the most important Companies in the world, because this certification implies an exacting control on the products fabricated in our facilities and services provided by our Company.
